This is especially important when applying thin set epoxy terrazzo and industrial flooring to concrete or cinder block walls for wainscot, column and base applications. Terroxy Primer's moisture insensitivity characteristics allow Terroxy Primer to be applied to damp concrete after proper surface preparation. In addition, the low modulus of elasticity and stress relieving properties of Terroxy Primer make it ideal for use as a binder for epoxy mortar systems and for patching and grouting applications.
